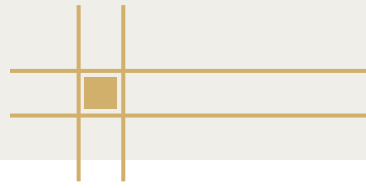
# SERVICE AREA

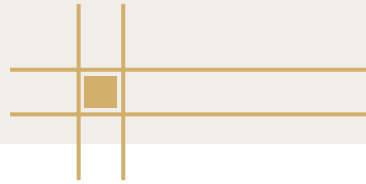
